❖ **QUALIFICATIONS AND EXPERIENCE**

**Post 1: Senior Scientist cum Head / Training Organiser - KVK**

**Essential Qualification:-**

**A) For Disciplines other than Engineering Subject**

Doctoral degree in relevant subject including relevant basic sciences with 8 years experience in the relevant subject as Scientist/ Lecturer / Extension Specialist or in an equivalent position in the pay band-3 of Rs. 15600-39100 with Grade pay of Rs.5400 / Rs.6000 / Rs.7000 / Rs.8000 having made contribution to research/ teaching/ extension education as evidenced by published work / innovations and impact.

**B) For Engineering Discipline**

Doctoral degree in relevant subject with 6 years experience as Scientist/ Lecturer / Extension Specialist or in an equivalent position in the pay band-3 of Rs. 15600-39100 with Grade pay of Rs.5400 / Rs.6000 / Rs.7000 / Rs.8000 having made contribution to research/ teaching/ extension education as evidenced by published work / innovations and impact.

**OR**

Master's degree in relevant engineering subject with 10 years experience as Scientist/ Lecturer / Extension Specialist or in an equivalent position in the pay band-3 of Rs. 15600-39100 with Grade pay of Rs.5400 / Rs.6000 / Rs.7000 / Rs.8000 having made contribution to research/ teaching/ extension education as evidenced by published work / innovations and impact.

**Desirable**

- 1) Candidate having specialization in implementing extension education programmes.

## **Post 2: Assistant / Superintendent cum Accountant - KVK**

- **Essential Qualification**

A Bachelor's degree from a recognized University.

- **Desirable**

Experience in Computerized Accountancy and preference will be given to the candidates having knowledge of Tally or such other Accounting Softwares.

### **SHORT LISTING CRITERIA**

The eligible candidates for the posts quoted at Sr. No. 01 and 02 will be shortlisted by the scrutiny committee of the University. The criteria for shortlisting will be decided by the competent authority of the University. The University reserves the right to call or not to call the candidates for further evaluation. The Procedure of shortlisting of the eligible candidates for the posts quoted at Sr. No. 01 and 02 will be as per general conditions and instructions at Sr. No. 11.

### **Evaluation of the Candidates:** (Only for the Post Sr. No.01)

The candidates, possessing minimum qualification as stipulated will be evaluated by the selection committee as per the marks given below.

- Academic Record and Research / Extension Performance (50%)
- Assessment of Domain Knowledge and Interview performance (50%)

### **Age Limit**

- a) The existing rules of the State Government in respect of age limit will be applicable for the advertised posts. The Maximum age limit will be 38 years for the candidates from open category and 43 years for the candidates from reserved categories.
- b) The maximum age limit is relaxable by five years in respect of Meritorious Sportsman.
- c) The maximum age limit for the persons with disabilities is 45 years.
- d) The age limit to the persons who are already in-service on regular establishment of state Agricultural Universities / Central Government / State Government / Semi-Government / other recognized Universities / Accredited grant-in aid colleges shall be as per Government Rule.

### **HOW TO APPLY**

Application in the prescribed format duly filled-in, in all respect along with the statement of bio-data and the copies of educational qualifications, experience, date of birth Certificate, School Leaving Certificate, reprints of research publications etc. duly attested by the competent authority should reach to the Registrar, Yashwantrao Chavan Maharashtra Open University, Nashik on or before **8<sup>th</sup> August 2022** positively. The application should be in the computerized format on "A-4" size paper.

The candidates who are already in service of this University / State Government/ Central

Government/ Semi-Government/ Other recognized Universities should apply through proper channel along with No Objection Certificate (NOC) from the present employer. Separate application for each post with separate fee should be submitted, failing which the application shall be rejected. Closing date for receipt of applications at YCMOU, Nashik, is **8<sup>th</sup> August 2022**.

**General conditions and Instructions**

- 1. The candidates if appointed will have to acquire requisite knowledge of computer application and to produce certificate as required under Government Resolution dated 19th March, 2003, within period of two years.
- 2. As per Government notification dated 28-3-2005, applicant is required to execute an undertaking that he/she does not have more than two living children after 28th March, 2005 in the form 'A'.
- 3. The candidates belonging to reserved categories should be "as notified by the Government of Maharashtra from time-to-time".
- 4. Incomplete application(s) and application(s) received after due date will not be considered. The University will not be responsible for postal delay or loss of application in transit.


5. The candidates should possess the required educational qualifications, age and experience as on **8<sup>th</sup> August 2022**.
6. As per the Government circular dated 03.07.2004 the experience of clock hours basis, periodical/part time job, on stipend, visiting professor/contributory lecturer, service without pay and worked as In-Charge Officer and holding additional charge will not be considered.
7. Mere eligibility of candidate(s) shall not vest in any right for calling for interview. University reserves its rights to call or not to call for the interview.
8. University reserves all rights to fill or not to fill-in any of the vacancies advertised. So also University reserves its right to give or not to give an appointment to the candidates though recommended by the Selection Committee.
9. The persons working outside this University should produce "No Objection Certificate" from their present employer, even though the application is received through proper channel, at the time of interview.
10. The candidate should himself/herself confirm his/her eligibility for the post applied for, before submission of application. No correspondence, whatsoever, in this regard shall be made / entertained.
11. In case, the numbers of applications received in response to this advertisement are large, the University may restrict the number of candidates for interview to a reasonable limit by adopting appropriate method.

17. The candidate will have to submit the relevant documents strictly as per his claim in application form, failing which, the candidature will be rejected.
