Hon'ble Vice-Chancellor, Yashwantrao Chavan Maharashtra Open University, Nashik is pleased to appoint the Academic Coordinator (Assistant Professor Level (Contractual)) in the enclosed list on the consolidated pay of Rs. 57700/- per month (fixed) from the date mentioned in the attachment or after the date of actual joining date, however, joining date shall be within 15 days from actual date of commencement of date of appointment on the following terms and conditions. The appointment is purely on temporary on contractual basis initially for a period of three months and may be extended as per exigency / need of the university and on the basis of satisfactory performance and progress report.

The terms and conditions of appointment are as follows:

- The nature of work, duties and responsibilities will be determined by the concerned Director of School / Division / Centre and Academic Coordinator shall be working under him / her.
- Academic Coordinator's appointment is of full-time nature. Working hours of university will be 10.00
 am to 5.45 pm. However, they will be required to work beyond the said time as per requirement.
- 3. Academic Coordinator shall have to submit activity carried out per day per month progress report of work through the Director to the Registrar for placing the same before Hon'ble Vice-Chancellor.
- 4. Academic Coordinator shall make all correspondence with their designation through the concerned Director.
- 5. Academic Coordinator will be entitled to 2 casual leaves and earned leave 7 for a period of three months.
- 6. During the period of appointment Academic Coordinator shall follow strict discipline, ethical academic values and or if he / she failed to carry out his / her duties and responsibilities, he / she shall be liable for disciplinary action.
- 7. Academic Coordinator's will have to submit a No Dues Certificate at the end of the contract in order to release the salary of the last month.

With reference to your application for the post of Training Associate being a Non-Teaching cadre in the Krishi Vigyan Kendra Project at this university in response to our advertisement dated May 2005 and subsequent interview, I am directed to inform you that, on approval by the Board of Management to the recommendations of the Selection Committee, you have been appointed as a Training Associate being a Non-Teaching cadre in Krishi Vigyan Kendra Project on basic pay Rs. 8000/- in the scale of Rs. 8000-275-13500/- with effect from the date on which you take over the charge of the post

 Your appointment is made subject for the approval of the statutes in respect of your post and service conditions by the Hon'ble Chancellor

The statutes so approved shall remain binding upon you.

- 2) Your appointment is on probation for a period of two years.
- 3) Agriculture increment, both during the period of probation, will depend upon a satisfactory evaluation of your work during the previous year. An unfavorable report from the Project Director may make you ineligible to receive an increment.
- 4) You will be required to perform the duties and responsibilities that will be assigned to you from time to time, by the KVK and University Authorities.
- Your work, performance and conduct shall be periodically assessed through an Evaluation Committee and any adverse remark in the report of the committee may make you ineligible to continue in the serveices of Krishi Vigyan Kendra.

- 6) If your acceptance is not received upto 1st, September, 2006 your appointment will be treated as cancelled.
- 7) You will be allowed to join duties on production of

 - Relieving order and Last Pay Certificate from the previous employer (if any)
 - Attested copies of all testimonials
- You are required to produce a certificate from your employer stating your position, grade, basic pay, allowances, annual date of increment and a statement that you are formally relieved from your duties.

- You will undergo Medical Examination by the medical officer appointed by the university for the purpose Dr. Vasant Pawar, Nashik or by the Civil Surgeon within one month from the date of joining the duties.
