2. Follow-up on CAS Applications from Previous Meeting (28th January 2025)

- o Prof. Dr. Sanjivani Mahale, reviewed the action taken on the decisions of the 28th Jan meeting.
- o Discrepancies noted in prior applications were resolved through applicant clarifications.

3. Scrutiny of New CAS Proposals

- Dr. Mohan Kherde and Dr. Madhukar Shewale led the scrutiny of newly received CAS applications.
- Each case was evaluated based on UGC regulations, verified API scores, and service records.
- Emphasis was laid on research publications, faculty development programmes, and annual performance indicators.

- Eligible candidates were shortlisted for the next level of Screening-cum-Evaluation Committee approval.
- Applications lacking documentation were returned for rectification and resubmission by a defined deadline.
- The committee stressed maintaining a transparent checklist and suggested maintaining digital records of all scrutiny outcomes.

o Dr. Shewale proposed introducing an internal orientation workshop on CAS guidelines and self-assessment documentation for all teaching staff.
