2. B.Sc. Programme Structure

2.1 Duration

The minimum duration of this programme is **Three** years, although student may complete the programme gradually with in maximum period **Eight** years.

2.2 Medium

The medium of instruction for the B.Sc. is **English.**

2.3 Multiple Entry and Exist System

The B.Sc. Programme is designed with **flexibility** to allow students to **enter and exit** at different stages based on their academic and personal needs. Each semester carries **22credits**, and the programme is as follows:

Entry Point:

- 2.3.1 Students typically enter the programme in the **first semester (1Year)** after qualifying as per admission criteria.
- 2.3.2 In Special cases (like lateral entry or credit transfer from recognized institutions), students may **enter at a later stage**, subject to eligibility and credit equivalency.

Exit Option:

- i. After 1 Year (2 Semesters / 44 credits):additional 4 credit core NSQF course/Internship with Certificate Exit with a Certificate in Media Graphics And Animation
- ii.After 2 Years (4 Semester / 88 Credits): an additional 4credit core NSQF course/Internship with Certificate Exit with a Diploma in Media Graphics And Animation
- iii. After 3 Years (6 semester / 132 Credits): Awarded B.Sc. Degree
- **2.4 Re-entry or Lateral Entry:** Students, opting for exits at any level, will have the option to re-enter the programme from where they had left off, in the same or in a different Higher education institution within three years of exit and complete the degree programme within the stipulated maximum period of seven years from date of admission to first year UG. Re-entry at various levels for lateral entrants in academic programme shall be based on the earned and valid credits as-deposited and accumulated in the Academic Bank of Credits (ABC) through Registered Higher Education Institutions (RHEI) and proficiency test records. Lateral entry into the programme of study leading to the UG Diploma/ Three year UG Degree will be based on the validation of prior learning outcomes achieved and subject to availability based on intake capacity.

- 1. **Open Elective courses** are interdisciplinary Courses that learners must choose from other Schools OE only.
- 2. The detailed guidelines regarding Co-curriculum courses (CC), Field project (FP) and On Job Training (OJT) shall be provided separately on the university's official website. The learners are advised to check website regularly for these guidelines and other announcements.
- 3. Learner can of choose any Co-curriculum courses (CC) from the basket in all semester.
- 4. Additional Nominal Fee for issuing Certificate in Media Graphics and Animation, Diploma in Media Graphics and Animation, and B.Sc. Degree Certificate after exit of First Year and second Year respectively may be applicable as per the university rules.
- 5. Learner can of choose any Open Elective courses (OE) from the basket in all semester
- 6. The learner should choose the same Ability Enhancement Courses for all semesters.
- 7. If there are any changes, the university holds the rights.

2.6 Credit Points

All courses offered carry a certain value in terms of credit-points. A credit point is a way of expressing the learning hours required to study a certain unit, in a book or a course.

Generally, one credit point is considered equivalent to about 30 learning hours. These learning hours could mean the time you spend in reading, note-taking, listening to lectures, participating in discussions on the topic, listening to audios, viewing especially prepared videos, etc. The learner requires earning 132 credit points in order to be considered eligible for the complete for the UG Degree of Bachelor of Media Graphics and Animation.

2.7 Learning Method

The students of the Open University do not go to the college every day. They do not have regular time for their studies. The Open University has independently developed a learning method for such students. This method has the following components:

- Self-Instructional material.
- Soft copy (PDF format) of study material is available on official website
- Counselling during contact sessions at the study Centre by the subject experts.

Special Features of the Study Material

The learners are given the online syllabus of the c o u r s e s and study material (PDF). The electronic versions of the study material (SIM- Self instructional material) are available on official website of the university (http://ycmou.digitaluniversity.ac). One can understand the study material through one reading because it is divided into small units. There are questions for each unit so as to revise and review the comprehension of the reading material. It helps the learners to study a specific topic .If the learner has any difficulty; he or she can make a note of it .He /she can discuss these noted difficulties with the counsellor during the contact session at the study Centre.

Nature of Contact Sessions

During the contact sessions, the counsellors are supposed to guide/discuss with the learners, based on the course material. The learners can solve their difficulties by discussing with their colleagues as well as with the counsellors during contact sessions.

Apart from this contact sessions, learners will have to attend practical as well as various training schedule conducted by the respective study centers.

3 Evaluation Procedure

3.1 Evaluation Pattern

The evaluation pattern of the Programme consists of the following components.

For major theory course of 100 marks, there will be 70 marks for University Assessment (End Examination [EE]) and 30 marks for Continuous Assessment (Home Assignments [CA]). University Assessment (End Examination) Learner will have to obtain minimum 40% marks to pass in each course in university assessment and continuous assessment separately. The marks obtained by the learner in Continuous Assessment will be shown separately in the Mark Sheet. **The Evaluation of all co-curricular (CC) courses will be done totally at respective study center only.**

(A) Internal Assessment (Continuous Assessment i.e. Home Assignment): 30 Marks The learners must submit neatly hand-written home assignments in hard copy format at Study Center, as per the schedule declared by the University. Learners should follow the university guidelines regularly and communicate with their respective Learner Support Centers for submission of their assignments within stipulated time. Assignments submission

for each course must be completed within the stipulated dates in the same semester of an academic year as communicated by the University.

Project Work / Practical / Viva-Voce: Evaluation of this component will be based either on Project Work/ Practical/Viva-voce OR all the three combination of these components as directed depending upon course contents.

3.2 End Examination (EE) –

Evaluation conducted at the end of the learning period through an examination. The End Examination will be of 70 marks for 4 credit courses and of 35 marks for 2 credit courses. The university will conduct end examination as per the schedule declared in advance. The learner will have to obtain minimum 40% marks to pass in each component.

The final result of the student after considering the performance for all academic years will be declared on the basis of the following:

- (A) Credit Based Semester System (CBSS): Under the CBSS, the requirement for awarding a degree or diploma or certificate is prescribed in terms of number of credits to be completed by the students.
- **(B)** Credit Point: It is the product of grade point and number of credits for a course.
- (C) Credit: A unit by which the course work is measured. It determines the number of hours of instructions required per week. One credit is equivalent to around 30 hours of learning activities.
- **(D)**Cumulative Grade Point Average (CGPA): It is a measure of overall cumulative performance of a student over all semesters. The CGPA is the ratio of total credit points secured by a student in various courses in all semesters and the sum of the total credits of all courses in all the semesters. It is expressed up to two decimal places.
- (E)Grade Point: It is numerical weight allotted to each letter grade on a 10-point scale.
- **(F)**Letter Grade: It is an index of the performance of students in a said course. Grades are denoted by letters O, A+, A, B+ B, C, P and F. The UGC recommends a 10-point grading system with the following letter grades and points as given below.

It is ratio of total credit points secured by a student in various courses registered in a semester and the total course credits taken during that semester. It shall be expressed up to two decimal places.
- **(H) Semester: Each** semester will consist of 15-18 weeks of academic work equivalent to 90 actual teaching days.
- (I) Transcript or Grade Card or Certificate: Based on the grades earned, a grade certificate is issued to all the registered students after every Semester. The grade certificate will display the course details (code, title, number of credits, grade secured) along with SGPA of the semester and CGPA earned till that semester.
- (J) All the generic electives shall be of theoretical in nature: They shall be implement educing online mode of delivery. The examination of such courses shall be conducted using online and on- demand methodology.
- (K) In assessing the performance of the students in examinations, the usual approach will be to award marks based on the examinations conducted at various stages (session, mid-term, end semester etc.) in a semester. The numeric marks obtained in such examinations shall be converted to appropriate letter grades. In order to avoid the variations, the UGC recommendations shall be followed. The following system to be implemented in awarding the grades and CGPA under the credit based semester system.

(L) Grading:

- i. The examinees shall be evaluated for internal assessment and end examination as per the evaluation pattern for the respective courses. The numerical marks in the aggregate shall be converted to the appropriate Letter grade and Grade point on prorate basis, i.e. using scaling down 100 marks to
- 10. Grade point scale. Thus, a person who has scored 46 marks out of maximum 100 marks in the aggregate shall get C (Average) Grade securing 5points.
- i.A student obtaining Grade F shall be considered failed and will be required to reappear in the examination.
- ii.For non-Credit Courses 'Satisfactory' or 'unsatisfactory' shall be indicated instead of the letter grade and this will not be counted for the computation of SGPA/ CGPA.
- iii. The Universities can decide on the grade or percentage of marks required to pass in a course and also the CGPA required to qualify for a degree taking into consideration the recommendations of the statutory professional councils such as AICTE, MCI, BCI, NCTE etc.

Computation of SGPA and CGPA

The following procedure to compute the Semester Grade Point Average (SGPA) and Cumulative Grade Point Average (CGPA) shall be followed:

(i) The SGPA is the ratio of sum of the product of the number of credits with the grade points scored by a student in all the courses taken by a student and the sum of the number of credits of all the courses undergone by a student, i.e.

$$SGPA(Si) = \sum (CixGi) / \sum Ci$$

Where Ci is the number of credits of the ith course and Gi is the grade point scored by the student in the ith course

1. The CGPA is also calculated in the same manner taking into account all the courses undergone by a student over all the semesters of a Programme, i.e.

$$CGPA=\sum (CixSi)/\sum Ci$$

- 2. Where Si is the SGPA of the ith semester and Ci is the total number of credits in that semester.
- 3. The SGPA and CGPA shall be rounded off to 2 decimal points and reported in the transcripts.

4. Transcript (Format): Based on the above recommendations on letter grades, grade points and SGPA and CGPA, the HEIs may issue the transcript for each semester and a consolidated transcript indicating the performance in all semesters.

Award of Degree: After successful completion of all courses at all years, the degree may be awarded, in person or absentia, during next convocation.

- 1. Preparatory programme of YCMOU with minimum 40% marks and completed 21 years of age.
- 2. H.S.C. or equivalent examination of Maharashtra or other state HSC Board.

- 4. Government recognized diploma of minimum two years after SSC. Eg.D.C.E., D.M.E., D.E.E.,D- pharma, Diary Tech., T.D, A.T.D, N.C.T.U.T.,I .T.I., M.C.V.C
- 5. Learner who have passed HSC OR equivalent examination from various board as approved by AIU from time to time.

■ Special Instructions

- (A) It is necessary to attach following documents along with application form.
 - (1)Attested photocopy of school leaving certificate or birth certificate.
 - (2)Attested copies of educational qualification.
- (B) Please do not attach any original document along with the application form. University will not be responsible for the same.
- (C) In case of change in name, it is allowed only at the beginning of the 1st year. To change the name Learners have to submit Notification in the Government Gazette to University.



Candidate/Student Agreement at the time of Admission

This is an agreement between the student or candidate and the YCMOU which is entered into by virtue of the candidate for admission clicking on "ACCEPT" button on the online admission portal at the time of admission to a program using online admission process.

In this agreement the term "candidate" is used to mean the person who proposes to take admission to a program in YCMOU and the term "student" is used to mean a person who has been admitted to a program of the YCMOU after fulfilling all the conditions thereof.

The candidate undertakes that -

- He has gone through the prospectus and the onscreen narrations or directions and has sincerely responded to the on-screen directions.
- 2. He has ensured that he is eligible to the program to which he proposes to take admission and that if it is found otherwise, (that is, if he is found not to be fulfilling the conditions of the eligibility at any time as per the rules mentioned in the prospectus or the on-line narrations) his admission will be summarily cancelled and the fees paid to the university will not be refunded in part or in full.
- 3. The information about the medium/mode of delivery of the Study Material (for example printed books, e-books, mobile app, audio/video material available on internet or through CD/DVD, etc) has been duly studied by me in the relevant pages of the prospectus and I have no objection to the said mode of delivery. He shall not make any demands on the methods or medium of delivery other than that mentioned in the prospectus.
- 4. He shall make any representations to the YCMOU by logging on as a student in respect of any activities of grievances within a period of thirty days from the date of cause of the grievances or by an email to the university at the designated e-mail address.

- 5. He understands that the University reserves right to make changes in the rules or syllabi or learning material or any other policy matter as a matter of urgency and that such changes in the rules, syllabi or policy matters shall be binding and applicable on him and that he shall not make objections to such changes.
- He shall not change his mobile number as registered with the University during the time of admission to the program.
- He understands that the University shall levy charges on changes in profiles of the student, including the photograph, mobile number, date of birth, etc.
- He understands that in case the University does not receive the fees from the Government (in case of Scholarship or Free-ship candidates), the student may be barred from taking examinations and his results shall not be declared till such time that the fees have been received.
- He understands that any incorrect or incomplete information given by him is liable to cancellation of his admission or withdrawal of degree or diploma awarded to him as and when the university gets to know of such supply of incomplete or incorrect information.
- 10. He shall visit the University's website (ycmou.digitaluniversity.ac and ycmou.ac.in) regularly and undertake necessary steps for academic and administrative purposes as expected from him including downloading of the examination hall ticket and printing the same.
- He shall undertake the studies of the academic program with necessary industry, discipline and honesty and conduct himself with due dignity and shall do nothing which is unbecoming of a student of the YCMOU.

There are a number of open Universities in the country of fering various degrees/diploma through the mode of non-formal education. The Open Universities have been established in the country by an Act of Parliament or State Legislature in accordance with the provisions contained in Section 2(f) of University Grants Commission Act, 1956. These universities are, therefore, empowered to award degrees in terms of Section 22(1) of the UGC Act, 1956.

A circular was earlier issued vide UGC letter N.F.1-8/92(CPP) dated February, 1992 mentioning that the Certificate, Diplomas and Degrees awarded by Indira Gandhi National Open University are to be treated equivalent to the corresponding awards of the Universities in the country

Attention is further invited to UGC circular No.F1-25/93(CPP-II) dated 28th July, 1993 (copy enclosed) for recognition of degrees and diplomas as well as transfer of credit for courses successfully completed by students between the two types of universities so that the mobility of students from Open University stream to traditional Universities is ensured without any difficulty.

The UGC has specified the nomenclature of degrees under Section 22(3) of the UGC Act, 1956 to ensure mandatory requirements viz. minimum essential academic inputs required for awarding such degrees. A copy of Gazette Notification regarding specification of degrees issued vide No.1-52/97(CPP-II) dated 31st January 2004 is enclosed. The details are also given in UGC Web site: www.ugc.ac.in

May, I therefore request you to treat the Degrees / Diploma / Certificates awarded by the Open Universities in conformity with the UGC notification on Specification of Degrees as equivalent to the corresponding awards of the traditional Universities in the country.

Guidelines for Pursuing Two Academic Programmes Simultaneously

Guidelines

- A student can pursue two full time academic programmes in physical mode provided that in such cases, class timings for one programme do not overlap with the class timings of the other programme.
- A student can pursue two academic programmes, one in full time physical mode and another
 in Open and Distance Learning (ODL)/Online mode; or up to two ODL/Online programmes
 simultaneously.
- Degree or diploma programmes under ODL/Online mode shall be pursued with only such HEIs which are recognized by UGC/Statutory Council/Govt. of India for running such programmes.
- Degree or diploma programmes under these guidelines shall be governed by the Regulations notified by the UGC and also the respective statutory/professional councils, wherever applicable.
- 5. These guidelines shall come into effect from the date of their notification by the UGC. No retrospective benefit can be claimed by the students who have already done two academic programmes simultaneously prior to the notification of these guidelines.

The above guidelines shall be applicable only to the students pursuing academic programmes other than Ph.D. programme.

Based on the above guidelines, the universities can devise mechanisms, through their statutory bodies, for allowing their students to pursue two academic programmes simultaneously as mentioned above.
